The National Gallery of Art announces the opening on Sunday afternoon, September 12th, of an exhibition entitled "Art for Bonds", composed of paintings by American artists designed for War bond poster use. The exhibition, which is an integral part of the Treasury's Third War Loan Campaign, is scheduled for showing at the Nation's capital during the time when that compaign is in progress throughout the country. It is designed to stimulate increased purchase of War Bonds and so supply the funds needed for the vast quantities of guns, ammunition, equipment, ships, planes, food and other requirements of our armed forces.

The exhibition is sponsored by the Treasury Department's

National Committee of Honorary Patrons, of which Hrs. Franklin

Delano Roosevelt is Honorary Chairman, and Hrs. Henry Morgenthau, jr

is Chairman. It is also sponsored by the Treasury Department's

conclusion of its Washington showing, the exhibition will go on

a circuit of other art museums throughout the country.

A selection of posters will be shown with the paintings from which they were made, so that the original and the reproduction in color can be compared. In the Foreword of the catalogue of the exhibition, Mrs. Henry Morgenthau, jr., Chairman of the National Committee of Honorary Patrons, says:

"Art for Bonds, a simple and literal title, differs from any exhibition with which I have been associated. It is an art exhibition challenging our interest in art. On the other hand its chief challenge, in the circumstances, is to our patriotism. Not only is its purpose to increase the sale of bonds, but inherently, picture by picture, everything in it was born to stimulate this patriotic activity. Whether you look at the preliminary sketches, at the completed paintings, at the posters reproduced from them, you see that the artist has been inspired by a patriotic motive. He has wished to increase the sale of bonds which not only support our war for freedom, and combat inflation, but insure a stable future."
